Cosmetic test ban

THE Federal Senate last Fri passed a bill which effectively bans all cosmetic testing on animals in Australia, with authorities to no longer accept animal testing results as proof of any product's efficacy or safety.

PHARMACIES are being urged to adopt a new "Software-as-a-Service" (SaaS) platform allowing remote monitoring of patient vital statistics, as a new revenuegenerating model for the sector.

Propell Health has been announced as the Australian partner for the iHealth Remote Monitoring Solution, which uses digitally-connected blood pressure monitors and pulse oximeters.

The system allows pharmacists to view alerts when customers' blood pressure and oxygen saturation levels are outside pre-determined thresholds, and with pricing based on a "per patient per month" model, gives pharmacies a new professional service focusing on chronic disease patients.

"The value of home monitoring and telehealth is reducing hospital admissions, and enabling the customer to have an active role in

Patient monitoring SaaS the management of their disease by tracking their blood pressure, oxygen levels, weight and blood glucose levels," said Propell CEO Craig Simmonds.

> Remote monitoring is already in place in several Australian Local Health Districts, Primary Health Networks and aged care organisations nationwide, he said.

Data from iHealth devices can also be integrated into other applications, while SaaS pricing for the system makes the offer "highly attractive" - propellhealth.com.au.

Repeat offender fails

THE Therapeutic Goods Administration (TGA) has issued Australian company, TK Imports

Wholesale Pty Ltd, an infringement notice alleging that the company unlawfully exported medicines from Australia.



The New Zealand Customs Service detained the goods at the border and referred the matter to the local medicines regulator Medsafe, which conducted laboratory analyses finding a number of undeclared prescription-only substances.

Medsafe contacted the TGA after identifying that the products had been exported from Australia in contravention of legislation that prohibits the export, import, manufacture and supply of items for human use that are not included on the Australian Register of Therapeutic Goods.

The TGA said the exporter was a repeat offender which was familiar with the legislation through previous dealings with the TGA.

TK Imports Wholesale paid the fine in full on 01 Feb and the investigation is now closed.

So it turns out fast food isn't always bad for the old heart, aye.

COMPLEMENTARY medicine (CM) exports from Australia almost tripled last year to more than \$930 million, according to new official statistics released yesterday.

The sector is a "real Australian success story," according to Carl Gibson, CEO of Complementary Medicines Australia.

"This is a real testament to consumers' healthy demand for these products, and when you also add in the sales through the ever-popular daigou channel, it is no wonder Australia is becoming China's major trading partner by capitalising on the new policy of cross-border e-commerce," he said. Gibson said many companies

in the complementary medicines industry were successfully capitalising on their local heritage by using the "Australian Made" logo and representations as a key quality advantage when exporting.

"Australia is commonly recognised as the world leader in the category for safety and quality, because we are one of the few countries who manufacture products as

medicines, not foods," Gibson said. However he warned use of the Australian Made collateral was at risk due to recent changes and newly implemented ACCC guidelines that "put our industry at a distinct disadvantage" (PD 04 Dec 2018).

Gibson made a personal plea to Minister for Industry Innovation and Science, Karen Andrews, saying given the export milestone being approached by the industry there were now "one billion reasons to back Australian manufacturers and back Australian high skilled jobs".

Illicit supply sentence

A BRITISH man has been sentenced to two years in prison after pleading guilty to illegally selling prescription-only medicine.

Keith Morgan was investigated by the Medicines and Healthcare products Regulatory Agency over supply of unlicensed erectile dysfunction treatments, after a tipoff by Royal Mail which found he had failed to pay the full postage on packages found to contain drugs.
