AHPRA review

PROCESSES and safeguards used to protect the confidentiality of health practitioners who report suspicious behaviour to the Australian Health Practitioner Regulation Agency (AHPRA) are currently under review.

The safety of notifiers has come to the fore in recent days after court documents revealed a GP was provided with the name of a pharmacist who flagged concerns over his prescribing of benzodiazepines, when he was notified that he was under investigation, and was later told where the pharmacist worked, before he went to the pharmacy and attempted to kill her (**PD** 04 Jul).

A spokesperson for AHPRA told *Pharmacy Daily* the regulator had engaged the National Health Practitioner Ombudsman and Privacy Commissioner, to review its practices and processes.

"The Ombudsman will consider the experience of other organisations with anonymous or confidential complaints both within and outside Australia," the spokesperson said.

AMA slams WA pharmacy proposals

expand the scope of pharmacists in Western Australia, to include limited prescribing rights and a broader range of immunisations have been blasted by the Australian Medical Association (AMA).

The WA Government's review of community pharmacy ownership laws, reported that pharmacists were under-utilised in the state and their skills could be used to alleviate pressure on medical services.

"Changes could be made to improve pharmacist utilisation, which is argued as needed to enhance efficiency of the health system," the review's authors said.

"These changes could include services to provide additional vaccinations, health screening, chronic disease management, health promotion, and other medicines-related activities. However, AMA WA President, Andrew Miller, warned pharmacists

"They're basically Dr Google with a shop," he said.

Pharmacy Guild of Australia WA Branch Director, Matthew Tweedie said the proposals were about "utilising the workforce you've got", rather than have pharmacists replacing doctors.

"The AMA's view of what this is... it's ill-informed," he said.

"No-one is planning to be the doctor... There is a role here for general practice and pharmacy to work together. We're happy to work with whomever to make that a reality for West Australians."

GP vax failures

NSW Health is investigating a number of GP clinics where breaches of vaccination guidelines have been identified, according to an *Australian Doctor* report. An audit of surgeries across the state had identified 44 "high-risk" practices and two clinics that failed to monitor vaccine fridge temperatures at all, contravening the guidelines for storage of the vials.

Unregistered nurse fined \$15,000

A VICTORIAN woman has been successfully prosecuted for falsely passing herself off as a registered nurse and injecting a patient with substances "purported to be cosmetic injectables".

Brittany Fairthorne pleaded guilty to charges relating to the incident at the Frankston Magistrates' Court, last week, after the Australian Health Practitioner Regulation Agency lodged proceedings against her.

Fairthorne was fined \$15,000 for breaching the Health Practitioner Regulation National Law, and ordered to pay costs of \$13,495.85.

AHPRA CEO Martin Fletcher welcomed the court's decision as a strong deterrent to anyone who

Health products advertising

THE Therapeutic Goods Administration (TGA) has posted a new summary of rules around safety claims when advertising health products. Advertisers are prevented

from claiming that their product is safe, that their use cannot cause harm, or that they have no side-effects.

Implied safety claims are also prohibited, such as claiming a product has a "safe mode of action", "no known side effects", is a "safe alternative", has "non-toxic amounts of..." or is "a safe alternative to prescription medicines without the debilitating side effects".

The TGA also placed emphasis on the inappropriate use of the word "natural" being used to imply safety.

Similarly the use of the word "organic" must not be used comparatively or suggestive of purity versus inorganic.

Even implications that an alternative product can be harmful is considered a safety claim and is not allowed. See details at tga.gov.au. falsely claims to be a registered health practitioner.

"This is another very good outcome for AHPRA, the Nursing and Midwifery Board of Australia and the public," he said.

"Claiming to be a registered health practitioner when you are not puts vulnerable people at serious risk.

"We will continue to take action against these individuals to support the profession and safeguard the public, including through prosecution in the criminal courts."

The case was heard just days after new tougher sanctions including increased fines of up to \$60,0000 and maximum jail sentenced of three years came into effect (*PD* 02 Jul).

Benefits of contacting PDL about incidents and near misses

SOME errors or incidents may seem trivial but PDL cannot stress enough the importance of contact at the time for advice and support. A Professional Officer will review the situation and determine if all steps have been taken to ensure the incident is not escalated. As well as receiving advice on incident handling, reporting the issue to PDL is a condition of insurance and provides a record which can assist with legal representation, if necessary. A copy of the incident report is provided which may be required by employers or for QCPP documentation.

Even if a wrongly dispensed item does not leave the pharmacy, it should still be reported as consumers can and sometimes do make a complaint to a pharmacy regulator. If a complaint is made and you have reported the matter to PDL, support is provided and legal advice is available, subject to the policy, to assist in replying to the complaint.

All incidents reported to PDL are collated and analysed for trends in common errors. From this analysis, PDL regularly sends practice alerts to its members alerting them to potential pitfalls. Past alerts are available in the PDL members section of the website.

A FUNERAL parlour worker in the USA has managed to escape a fine for driving in a car pool lane, on a somewhat dubious technicality.

The mortician was pulled over by the Nevada Highway Patrol while driving in a socalled "HOV Only" lane (high occupancy vehicle) because he was the only person in the car.

However, he successfully argued that there was also a dead body in the back of the hearse, meaning technically there were two occupants.

A group of pioneering British female health professionals have been awarded posthumous honorary degrees in medicine, after being prevented from graduating from their courses in the 1870s.

The so-called "Edinburgh Seven" were the first women admitted to study medicine in Britain, but were ultimately prevented from qualifying as doctors, according to the BBC.

Their attempts to study caused a riot at the University of Edinburgh's Surgeons Hall, where they were pelted with mud when they attempted to sit an anatomy exam.

The degrees were awarded this week, on the 150th anniversary of their matriculation.
