RSV vax access critical

THE PSA is calling on all Govts to allow pharmacists to administer the recently approved first respiratory syncytial virus (RSV) vaccine, as it would "significantly improve its uptake" and reduce hospitalisations from severe infections

"Having a vaccine on the market is not enough, we need to ensure that it's as accessible as possible to those who need it most," said PSA President Fei Sim (pictured).

"Pharmacist immunisers are limited by red tape and regulation imposed by states and territories, preventing them from fulfilling their potential to administer all vaccines to all at-risk Australians."

Millions of Australians attend pharmacies for their vaccinations. with more than 15 million COVID-19 and influenza vaccines administered by pharmacists over the last few years, PSA stated.

"By making vaccinations more accessible to vulnerable groups, we can limit the serious health complications RSV can cause and in



turn reduce hospitalisations."

Sim added that allowing pharmacists to practice to the top of their scope makes efficient use of health resources, benefitting the broader health system.

"I urge all state and territory govts to authorise pharmacists to provide the RSV vaccine, supporting access to preventive care and keeping older Australians healthy and well," she urged.

"This access should extend to all vaccines, for all eligible people, in all locations in Australia where pharmacists work.

"Reducing barriers to vaccination, reducing barriers to care, should always be our priority," Sim said. JG

Disqualified in Vic

A VICTORIAN pharmacist had his registration cancelled and has been disqualified from reapplying for registration for 12 months for inappropriate behaviour with three female clients and inappropriate dispensing of medicines.

In 2019, the Pharmacy Board of Australia received two separate notifications in Nov and Dec about Mina Tawadros, leading it to take action in Feb 2020 and accept an undertaking from Tawadros not to practise while they investigated.

One month later, the **Board referred Tawadros** to the Victorian Civil and Administrative Tribunal alleging professional misconduct involving failure to supply a prescription med, transgression of professional boundaries with three female clients, and supply of an S4 med exceeding what was prescribed.

Dispensary Corner

THOSE retail pharmacies looking to increase their foot traffic could learn from France's postal service, which is experimenting with opening changing rooms in some branches to cater to online shoppers who want to quickly return purchases that don't fit.

In a Paris post office participating in the test, a stand-alone changing room in the shape and canary yellow colour of a French mailbox has been installed.

The room has a chair, mirror, and shelf to place your package for on-the-spot returns.

France's La Poste said the idea came about after seeing many customers pick up their packages only to return shortly thereafter as their purchases didn't fit.

"The idea is to simplify the lives of our clients," said the company, letting them receive the merchandise, check it out on the spot and, in the event of a poor fit or a change of mind, send it back.

"It helps people avoid making pointless trips back and forth and save time, it's practical," said client Michele Limouzy, adding she nevertheless prefers to buy clothes in shops.

La Poste also hopes the experiment will boost traffic.



NAPSA Wildcard winner



THE Pharmacy Student of the Year Wildcard entry has been awarded to McKinlay Nolan from the University of Tasmania last Fri at the National Australian **Pharmacy Students Association** Congress in Hobart.

Nolan will join state and territory finalists to compete in the national Pharmacy Student of the Year competition at PSA24 this Aug, where they will be tested with a real-life clinical situation and will respond using their clinical knowledge and communication.

Announcing the wildcard winner, Pharmaceutical Society of Australia (PSA) CEO Adj/Prof Steve Morris congratulated students on their outstanding performance in the national competition.

PBS listing 01 Feb

THE Federal Health Minister Mark Butler announced the PBS listing of Australia's first combined anti-programmed cell death protein 1 (PD-1)/ anti-lymphocyte-activation gene 3 (LAG-3) treatment for adult and paediatric patients aged 12 years or older with unresectable or metastatic melanoma, effective 01 Feb, at a morning press conference held at The Queen Elizabeth Hospital, Adelaide, yesterday.

Bristol Myers Squibb's Opdualag (nivolumab/ relatlimab) is a fixed-dose combination of nivolumab, a PD-1 inhibitor, and relatlimab, a novel first-in-class lymphocyte-activation gene LAG-3-blocking antibody, which restores the effector function of exhausted T-cells and promotes antitumour activity.

Co-Medical Director of Melanoma Institute Australia, and 2024 NSW Australian of the Year, Prof Georgina Long, said, "inhibiting LAG-3 with relatlimab, in combination with nivolumab, gives us a new treatment to add to our toolkit against melanoma".

Impacts driving

CANNABIS can impact driving ability among older, long-term users of the drug, according to a small Canadian study published in JAMA.

The researchers recruited 31 participants aged 65-79-yearsold and monitored them on a driving simulator, finding signs of impairment, such as weaving, speed changes, and delayed reaction time, after 30 minutes of driving.
