Assistants Day

TODAY, the Pharmaceutical Society of Australia (PSA) is celebrating Pharmacy Technicians and Assistants Day, recognising dedicated pharmacy support staff around the country.

PSA National President, Associate Professor Fei Sim emphasised the vital role played by pharmacy assistants and technicians.

"The clinical support that technicians and assistants provide allows pharmacists to extend their focus to undertaking clinical roles and practising to their full and top of scope," Sim said.

"Their contribution to the overall team capacity and efficiency is invaluable."

Sim also encouraged all pharmacists to take the time today to acknowledge the dedication and hard work of their technicians and assistants.

IN A push to ensure equitable access to financial support, the National Australian Pharmacy Students' Association (NAPSA) is spearheading a new campaign to expand the government's proposed student placement payment program beyond nursing and medical degrees.

NAPSA President Sebastian Harper told Pharmacy Daily he spoke to the Senate committee examining the Universities Accord (Student Support and Other Measures) Bill 2024, advocating for the inclusion of a range of allied health degrees, including physiotherapy, occupational therapy, and speech pathology.

"We're really proud to be championing the cause of other allied health groups," said Harper.

"There's no other national health student body like NAPSA for all these other degrees, so we're stepping up to make sure their voices are heard."

NAPSA's campaign aims to secure the inclusion of all health degrees before Jul next year, when the proposed bill comes into effect.

The Senate committee's report acknowledged the need for broader inclusion, specifically mentioning the Pharmaceutical Society of Australia's submission.

However, the government's current plan is to initially limit the payments to nursing, social work, and midwifery students, with a potential review after 12 months.

Harper expressed concerns about the government's timeline, noting that a year would not provide sufficient data to evaluate the

program's effectiveness.

Prac payments campaign

"It's just not going to show much as you need five years or so to see how the program has affected students and degrees," he said.

An interesting insight from Harper is the potential long-term impact of NAPSA's involvement in the legislative process which has led the student body into "conducting proper advocacy".

Harper highlighted the similarities in placement requirements and that there are a high proportion of women in pharmacy and allied fields as key reasons for inclusion.

These are the same reasons that the government stated when introducing prac payments for nurses, midwives, and social workers earlier this year.

"Most of them have similar requirements, and are doing hundreds or even thousands of hours of unpaid placement."

"So, a lot of these other degrees also hit that criteria," he explained.

With growing momentum and support from allied health groups, NAPSA remains cautiously optimistic about its success.

Harper noted that the government has not yet shown a willingness to expand the program, but he believes that persistent advocacy can lead to positive change, as it has in the past. "It might be an uphill battle, but

it's always an uphill battle to get change in Australia.

"It does happen, and it's happened before.

"Good campaigns and advocacy from groups like NAPSA can actually get change," he concluded. JG

CRIMINALS have come up with a myriad of ways to try to hide drugs, but one drug dealer in Portland, Oregon, took the "hidden in plain sight" approach.

After stopping a driver and passenger inside an allegedly stolen vehicle, police discovered a stash of drugs alongside cash and a loaded firearm in a bag ironically labelled 'definitely not a bag full of drugs'.

Despite the claim on the vanity case, more than 10g of fentanyl and meth was reportedly found inside, leading to the arrest of a man and a woman.

The pair now face charges of drug possession and possession of a stolen vehicle.



CW QR payments

CHEMIST Warehouse has introduced the option to pay by QR code, in a bid to cut transaction fees charged by Visa and Mastercard.

Thanks to the pharmacy retail chain's new partnership with fintech firm Waave, shoppers can pay directly from their banks at checkout by scanning a code and entering their account details.

Key findings include a 470% faster absorption rate, with Spontan reaching peak plasma concentration in 12 minutes, compared to 56 minutes for oral tablets.

Despite using half the dose, Spontan showed 111.8% dosenormalised bioavailability and a 155.6% higher peak concentration, suggesting comparable efficacy with a lower dose.

The formulation was welltolerated, with no serious adverse events reported.

Chief Medical Officer Prof Geoffrey Strange noted the potential of Spontan to address unmet needs in ED treatment, highlighting its speed of absorption and favourable safety profile.



"These results offer patients a more spontaneous and convenient therapeutic option." he said.

The study, involving 18 healthy adult males, compared Spontan to oral tablets over 24 hours, confirming its faster onset and comparable bioavailability.

Chairman Lee Rodne added, "these results position LTR Pharma to advance commercialisation efforts, regulatory discussions, and strategic partnerships, reinforcing our commitment to delivering innovative solutions for patients". JG

Seizure safety highlighted this month

FOR Seizure Safety Month this Oct, Epilepsy WA is urging people to take seizure risk reduction seriously, highlighting the 300+ Australians who die each year from epilepsy-related causes.

More than half of those deaths are due to Sudden Unexpected Death in Epilepsy (SUDEP), where a person living with epilepsy dies without warning and the postmortem fails to establish another cause of death.

The community can take action by learning seizure first aid, while

people with epilepsy should take medications as prescribed, avoid known seizure triggers, and ensure they get adequate sleep.

"One in 25 people will be diagnosed with epilepsy, and the number who lose their lives to this chronic condition is totally unacceptable," said Epilepsy WA CEO, Emma Buitendag.

Additionally, for SUDEP Action Day tomorrow, Perth Railway station will shine purple in honour of those who have lost their lives to the condition.
