Have a say in medicine decisions

THE Department of Health, Disability and Ageing is seeking expressions of interest from suitably qualified and experienced individuals - including pharmacists and pharmacologists - who would like to be considered for upcoming member vacancies on national health technology assessment (HTA) committees and sub-committees.

These include the Medical Services Advisory Committee (MSAC), Pharmaceutical Benefits Advisory Committee (PBAC) and Drug Utilisation Sub Committee (DUSC), which provide independent expert advice to the Minister for Health, Ageing and Disability. EOIs close 15 Dec 2025 - learn more HERE.

Mayne kills off Cosette sale

THE planned sale of Mayne Pharmaceuticals to US pharma company Cosette has been called off today, with Mayne providing Cosette with notice that it has terminated the scheme implementation deed due to Cosette's breaches of the scheme.

The notice brings to an end a rollercoaster ride that began in Feb this year (*PD* 21 Feb), when Cosette agreed to buy Mayne for around \$672 million based on the share price at the time.

By June, when Mayne shareholders overwhelmingly voted in favour of the acquisition, Cosette had twice attempted to abandon its takeover bid, citing "material adverse change" after weaker-than-expected earnings guidance.

Cosette also pointed to a possible US regulatory issue with one of Mayne's key products, Nextstellis contraceptive pill, with the FDA flagging misleading claims about its risks.

Mayne Pharma rejected the validity of the Cosette's termination notices and commenced proceedings in the Supreme Court of New South Wales to establish that no material adverse change had occurred and the Scheme remained valid - with the Court finding in favour of Mayne.

Proceedings took another turn in Oct when the Australia's Foreign Investment Review Board (FIRB) raised a further obstacle to the Scheme, suggesting that Cosette's acquisition may be "contrary to the national interest".



The FIRB cited concerns that Cosette intends to shut or divest Mayne's TGA and FDA approved manufacturing facility in Adelaide, a plant recently bolstered by an \$18 million upgrade and federal grant support.

In an ASX statement today, Mayne said it intends to enforce the costs order against Cosette arising from the Supreme Court of NSW case, and will keep shareholders informed of any further developments in relation to the termination of the Scheme, KB

Ayurvedics safety warning

THE Therapeutic Goods
Administration (TGA) has
issued safety advisories for
several Avurvedic medicines
contaminated with extremely
high concentrations of heavy
metals, including mercury,
lead, arsenic and cadmium.

The affected products are:

- Brahmi Vati tablets (Unjha Ayurvedic Pharmacy)
- Kumar Kalyan Rasa tablets, (Unjha Ayurvedic Pharmacy)
- Manasamitra Vadakam tablets (SKM Siddha and Ayurvedha).

None of the products have been assessed by the TGA for quality, safety or efficacy.

The TGA noted it had previously issued safety advisories for unregistered Ayurvedic products.

"Despite these warnings, we continue to intercept unregistered Ayurvedic medicines imported into Australia that contain dangerous levels of heavy metals and other controlled or prohibited ingredients," the regulator stated - more HERE.

Ad breach fine


THE Therapeutic Goods
Administration (TGA) has put
sponsors of low-risk listed
medicines on notice after
fining functional food company
Perdays Australia \$19,800
for the alleged unlawful
advertising of a listed medicine,
in contravention of the
Therapeutic Goods Act 1989.

Sponsors are permitted to supply low risk listed medicines to consumers, without the need for premarket assessment of efficacy, quality, and safety by the TGA.

"The TGA will continue to take action where non-compliance with the Act is identified in accordance with our regulatory compliance framework," the regulator warned.

No health checks for older doctors

AFTER consulting on possible compulsory health checks for late career doctors, the Medical Board of Australia has opted to pursue "a more nuanced and collaborative solution" instead.

An analysis of the outcome of complaints to Ahpra showed that the issues requiring regulatory action for doctors aged over 70 most commonly include concerns about communication, clinical care, pharmacy and medication, as well as health.

The Board said it will work with the medical profession on strategies to support late career doctors to keep practising safely as they age.

"The Board values the contribution of late career doctors to their patients, the medical profession and our community," Medical Board of Australia Chair, Dr Susan O'Dwyer, said.

"There are also some clear issues in the practice of some doctors in this group that health checks alone won't address," she explained.

"We are keen to collaborate with the profession on supporting this group of doctors to keep their practice safe and their knowledge and skills up to date," she said, noting the Board is working to find "a proportionate solution to a nuanced and sensitive problem".



Dispensary Corner

A MAN who claims to be the "healthiest patient" his doctor has ever seen has kindly shared his secrets to his 795,000 Instagram followers, and it doesn't include protein powder or fancy supplements.

Longevity researcher and best-selling author Dan Buettner, aged 64, credits his nonrestrictive plant-based diet as the reason behind his vitality.

He revealed he starts his day with a humble bowl of Sardinian minestrone - a vegetable soup of beans that he tops with a dash of olive oil and an avocado.

Buettner's own research across global Blue Zones, which are geographic regions with a high concentration of centenarians, has revealed that diets rich in legumes, greens and unrefined carbohydrates are strongly linked to reduced chronic disease, lower inflammation and significantly longer lifespan.

As for the rest of his day, Buettner snacks on fruit.

"I usually let myself eat as much fruit as I want, and I eat the food that appeals to me that day because then I'll keep eating it," he said in a recent video that has attracted 150,000 views.

Buettner's dinner habits may surprise you though - he goes out to eat every single night, describing how maintaining a social life is key to living long.

"I eat mostly a whole food, plant-based diet, but I also know being connected socially is part of that cluster of factors that leads to 100," he explained.

"I eat healthy, I stay connected, I feel pretty good."

Meet pharmacy's next generation

WORKING in John Hunter Hospital's patient care system are two teenage pharmacy assistant trainees, Madison Brown and Alison Silva (pictured), who are currently completing their Certificate III Hospital and Pharmacy Support.

The traineeship is offered through the NSW Government's '1000 NSW Public Sector Apprentices and Trainees Program', a commitment to employ an additional 1,000 learners across state government agencies and state-owned corporations over three years.

Under the program, apprentices and trainees can earn and learn while on the job, gain practical experience, be mentored by industry experts and earn nationally recognised qualifications.

Silva is attending one day per week while doing her HSC at school, while Brown has chosen the pathway as an alternative to school.

Silva and Brown are among the 20 percent of Aboriginal and Torres Strait Islander learners in the program, and both hope to inspire other First Nations people by showing them what is possible.

"Being an Indigenous woman, some people think you're not going to get as far as other people and reach the same levels people can - me doing a school-based apprenticeship and traineeship and showing up changes that," Silva said.

Silva and Brown conduct tasks such as monitoring fridge temperatures to ensure medications can be safely administered; scanning and taking stock of wards; dispensing medicine and supporting outpatient discharges; and delivering medication to wards.

Both are enjoying the opportunity to get a taste of working in healthcare in general, and pharmacy in particular, and plan to continue their studies in the field.

Supervised and mentored by Tracey Meares, Deputy Services Manager at John Hunter Hospital, the trainees have impressed those around them as they uplifted the team culture and workload while gaining hands-on skills in the supporting role and safe management of medicine.

"Having them both on board has changed the working environment," Meares said.

"They are significant contributors to our team, and not just as trainees - they do the same work as the other technicians and add to the team culture."

As for the future, the Certificate III in Hospital and Pharmacy Support can lead to a Certificate IV and a technician qualification, and that is a path Silva intends to pursue



initially as she decides on the direction she wants to follow.

Brown, on the other hand, is looking into university studies to become a pharmacist.

Meanwhile, the team at John Hunter Hospital are also keen to continue with the program.

"This has been a really positive experience and we're very happy we've chosen to do it - and these two have been exceptional," Meares told *Pharmacy Daily*, adding that they will have another trainee next year as well. *KB*
